## SC Unit 1 & Unit 2 Online Self-Paced Courses

Complete the 90-hour South Carolina licensing courses around your schedule. You must be at least 18 years of age to register. Students have access to the online materials for up to six months. Upon successful completion of the course, Comps will issue the student's certificate



### Online NORTH CAROLINA PRE-LICENSE

Complete your 75-hour North Carolina Broker licensing course around your schedule. You must be at least 18 years of age to register. Students have access to the online materials for up to six months. Comps will issue the student's certificate after successfully completing the course.



## **Online Self-Paced Post Licensing**

Provisional Brokers must complete an additional 90 hours of Post Licensing courses, 301, 302, & 303, within 18 months from initial licensure to obtain a full NC Broker license. Students must already be licensed before they may enroll in post-licensing courses. The North Carolina Real Estate Commission will not grant post-licensing credit to students who started post-licensing courses before they received their real estate license.



## SC: Mandatory Continuing Education Courses Associate and Broker licensees with an expiration date of June 30 must complete 6 hours of Electives and 4 hours of

mandatory Core continuing education courses to enable them to renew their credentials.



Core: 2024- 2026 Courses

Brokers-in-Charge licensees must complete a mandatory 4-hour Broker-in-Charge, 4 hours of Core, and 2-hour Elective continuing education courses to enable them to renew their credentials.
